Sub: Affiliation – R.K. Degree College, Golconda X Roads, Musheerabad, Hyderabad. – Irregularities in conduct of B.Sc Supplementary Examinations – Violation of University norms – Issue of Disaffiliation Orders from the academic year 2018-19 – Resolution of the Executive Council - Reg.

The University has received a report from the Controller of Examinations, OU with regard to the indulgence of the Management of R.K.Degree College, Golconda X Roads, Musheerabad, Hyderabad in Malpractice, impersonation, forgery, cheating in conducting B.Sc supplementary examinations held in September/October, 2017. In the report he has stated that, while segregating the answer scripts they have found two answer scripts with different serial numbers pertaining to one single student and therefore the result of the student was withheld. Subsequently, when the student approached the Examination Branch for results, they have directed him to submit the D form (attendance statement). Accordingly the student has brought the D form (attendance statement) from the R.K.Degree College. On verification of the D form submitted by the student and of the D form submitted by the R.K.Degree College it is found that two answer booklets with different serial numbers were issued to the student. One answer booklet consisting the stamp of Chief Superintendent and other consisting the stamp of the Principal. On further verification/enquiry it is observed that the Academic Audit Cell, OU has allotted different examination centers to (52) different students, but all of them have written examinations at R.K. Degree College (College Code : 1138).

Based on the above report submitted by the Controller of Examinations, OU a Show Cause Notice was issued to the Principal/Correspondent, R.K.Degree College, Golconda X Roads, Musheerabad, Hyderabad calling for explanation for indulging in Malpractice, impersonation, forgery, cheating and violation of University rules in conducting B.Sc Supplementary examinations.

In reply to the above Show cause Notice, the Principal of the college has submitted the explanation that they have received a phone call on the landline which was received by their office staff who has informed the Principal that the University has allotted some students to their college and instructed to conduct examinations at their centre.

Subsequently, the University has constituted a Committee to examine the explanation submitted by the college and to suggest further course of action.

Accordingly, a meeting of the Committee was convened on 07-05-2018. The Committee after thorough discussion of the matter has opined that the explanation submitted is unsatisfactory, vague, untenable and without any proper evidence. The Committee also noticed that a police case is registered against the R.K. Degree College and the Principal of the college is also arrested. Subsequently, the case is transferred to CCS and the investigation is in progress.

Based on the above observations, the Committee has opined that, it is evident that the college has committed gross irregularities and violated University rules and regulations in conducting examinations and made the following recommendations:

1. To disaffiliate R.K. Degree College, Golconda X Roads, Musheerabad, Hyderabad (college code : 1138) from the academic year 2018-19.
2. To transfer the students who are on rolls in 2<sup>nd</sup> and 3<sup>rd</sup> year of the college to other near by colleges from the academic year 2018-19 as per the prevailing norms of the University.

The above recommendations of the Committee were submitted to the Standing Committee of the Academic Senate for its approval. The Standing Committee of the Academic Senate at its meeting held on 21-05-2018 resolved to approve the recommendations of the Committee **for disaffiliation of R.K. Degree College, Golconda X Roads, Musheerabad, Hyderabad. (College code : 1138) from the academic year 2018-19 and to transfer the students on rolls to other nearby colleges from the academic year 2018-19 as per the prevailing norms of the University.**

Subsequently, the recommendation of the Standing Committee of the Academic Senate, the report of the Controller of Examinations, OU, Show Cause Notice issued to the Management of R.K. Degree College, and the explanation submitted by the College Management and other relevant documents were placed before the Executive Council for its consideration. The Executive Council in its 149<sup>th</sup> meeting held on 20-06-2018 after careful perusal of all the documents, **resolved to approve the recommendations of the Standing Committee for disaffiliation of R.K. Degree College, Golconda X Roads, Musheerabad, Hyderabad. (College Code : 1138) from the academic year 2018-19 and to transfer the students on rolls to other nearby colleges from the academic year 2018-19 as per the prevailing norms of the University.**

**In view of the above decision of the Executive Council, R.K. Degree College, Golconda X Roads, Musheerabad, Hyderabad. (College Code : 1138) is hereby disaffiliated to offer UG Courses from the academic year 2018-19.**
